

MSDS Requirements

Please be advised that under 29CFR 1910.1200, the DentaPure[®] line of products is exempt from the MSDS requirements of the federal regulation.

Specifically, DentaPure® is exempt under Sections:

- 1910.1200(b)(5)(i), any pesticide as such term is defined in the Federal Insecticide, Fungicide, and Rodenticide Act (7 USC 136 et. seq.), when subject to the labeling requirements of that act and labeling regulations issued under that act by the Environmental Protection Agency. DentaPure[®] is also registered with the USEPA as an antimicrobial. DentaPure[®] product line registered as EPA registration number 74245-5.;

NAME: Microbiological Water Purification Cartridge

TOXICITY HAZARDS

Hazardous Components: Contains Iodine on a proprietary resin.

Effects of Overexposure: Can irritate eyes, nose, throat and skin, hypersensitivity, nausea, abdominal pain,

diarrhea, excessive thirst circulatory failure. Possibly fatal if swallowed.

Drying results in release of iodine vapor.
